Statement of Principles

concerning

SOFT TISSUE SARCOMA

ICD CODE: 164.1, 171

Veterans' Entitlements Act 1986 subsection 196B(3)

- 1. Being of the view that, on the sound medical-scientific evidence available to the Repatriation Medical Authority, it is more probable than not that **soft tissue sarcoma and death from soft tissue sarcoma** can be related to eligible war service rendered by veterans and defence service rendered by members of the Forces, the Repatriation Medical Authority determines, under subsection 196B(3) of the *Veterans' Entitlements Act* 1986, that the factors that must exist before it can be said that, on the balance of probabilities, **soft tissue sarcoma or death from soft tissue sarcoma** is connected with the circumstances of that service, are:
 - (a) in relation to Kaposi's sarcoma, being infected with HIV before the clinical onset of soft tissue sarcoma; or
 - (b) having a course of therapeutic radiation before the clinical onset of soft tissue sarcoma to the area in which the sarcoma develops;
 - (c) inability to obtain appropriate clinical management for soft tissue sarcoma.
- 2. Subject to clause 3 (below) at least one of the factors set out in paragraphs **1(a) to (c)** must be related to any service rendered by a person.

- 3. The factor set out in paragraph **1(c)** applies only where:
 - (a) the person's **soft tissue sarcoma** was contracted prior to a period, or part of a period, of service to which the factor is related; and
 - (b) the relationship suggested between the **soft tissue sarcoma** and the particular service of a person is a relationship set out in paragraph 8(1)(e), 9(1)(e) or 70(5)(d) of the Act.
- 4. For the purposes of this Statement of Principles:
 - "a course" means five or more episodes of treatment within a 125 day period;
 - "being infected with HIV" means serological evidence of infection with human Immunodeficiency Virus, attracting an ICD code in the range 42 to 44;
 - **"ICD code"** means a number assigned to a particular kind of injury or disease in the tenth edition of the *International Classification of Diseases* 9th Revision, effective date of 1 October 1993, copyrighted by the US Commission on Professional and Hospital Activities, and having the Library of Congress number 77-94472;
 - "ICD morphology code" means a number assigned to the morphology of a particular neoplasm in Appendix A of the tenth edition of the *International Classification of Diseases* 9th Revision, effective date of 1 October 1993, copyrighted by the US Commission on Professional and Hospital Activities, and having the Library of Congress number 77-94472;
 - "Kaposi's sarcoma" means a neoplastic disorder of mesenchymal origin, with interweaving bands of spindle cells and vascular clefts or slits, attracting an ICD morphology code of M9140\3;
 - "soft tissue sarcoma" means a diverse group of malignant neoplasms of mesodermal origin which arise in the soft somatic tissues that occur within and between organs, attracting ICD code 164.1 or 171;
 - "therapeutic radiation" means electromagnetic radiation, including gamma rays, alpha particles and beta particles, deliberately applied for the purposes of medical treatment.
