# Statement of Principles

concerning

## **DENGUE FEVER**

ICD CODE: 061, 065.4

### Veterans' Entitlements Act 1986 subsection 196B(2)

- 1. Being of the view that there is sound medical-scientific evidence that indicates that **dengue fever** and **death from dengue fever** can be related to operational service rendered by veterans, peacekeeping service rendered by members of Peacekeeping forces and hazardous service rendered by members of the Forces, the Repatriation Medical Authority determines, under subsection 196B(2) of the *Veterans' Entitlements Act* 1986 (the Act), that the factors that must as a minimum exist before it can be said that a reasonable hypothesis has been raised connecting **dengue fever** or **death from dengue fever** with the circumstances of that service, are:
  - (a) being exposed to dengue viruses types 1, 2, 3, or 4 not more than eight days before developing the disease; or
  - (b) inability to obtain appropriate clinical management for the dengue fever.
- 2. Subject to clause 3 (below) at least one of the factors set out in paragraphs **1(a) to 1(b)** must be related to any service rendered by a person.
- 3. The factor set out in paragraph **1(b)** applies only where:

- (a) the person's **dengue fever** was contracted before a period, or part of a period, of service to which the factor is related; and
- (b) the relationship suggested between the **dengue fever** and the particular service of a person is a relationship set out in paragraph 8(1)(e), 9(1)(e), 70(5)(d), or 70(5A)(d) of the Act.
- 4. For the purposes of this Statement of Principles:

"dengue fever" means a viral infection due to dengue viruses types 1, 2, 3, or 4, attracting ICD code 061 or 065.4;

"endemic area" means an area described in the Schedule to this instrument;

"exposure to dengue viruses types 1, 2, 3, or 4" can be presumed if the person was in an endemic area at a time when the Schedule specifies that the area was endemic for those viruses;

"ICD code" means a number assigned to a particular kind of injury or disease in the tenth edition of the *International Classification of Diseases* 9th Revision, effective date of 1 October 1993, copyrighted by the US Commission on Professional and Hospital Activities, and having the Library of Congress number 77-94472.




